Brenda Amburn was here to thank the Town of Parker City and the town council for the memorial bench for Rex Amburn that has been placed outside of the front entrance to the city building.

Jimmy stated that there are 2 clarifiers at the sewage plant that are chain driven that are in need of repair. He received a quote in the amount of \$90,000.00 for making new parts and \$10,000 from Culy's to repair the clarifiers. Jimmy has talked with Mick and they believe that they have come up with a plan to repair the clarifiers. There was also a discussion on the spending of the ARP monies. It is stated that it can be used for water & sewage infrastructure. Jimmy has heard that there is more money available for projects. We will check into this further.
