William opened the meeting,

Scott made a motion for William Greer to be president of the Parker City Town Council for 2024, Rick seconded, William accepted the nomination, all voted in favor.

Rick made a motion to accept the synopsis of the December 7, 2023 meeting, Scott seconded, all voted in favor.

Scott made a motion to accept Resolution 2024-1 Payment of Bills and Payroll, Rick seconded, all voted in favor.

Scott made a motion to accept Resolution 2024-2 Payment of IACT & ILMCT Dues, Payment of Meter Deposit Refunds, Rick seconded, all voted in favor.

Scott made a motion to accept Resolution 2024-3 Allowing the investing of funds, Rick seconded, all voted in favor.

Scott made a motion to accept Resolution 2023-4 Designating The News Gazette for legal advertising, Rick seconded, all voted in favor.

Scott made a motion to accept Resolution 2024-5 appointing Doug Lankford to be Parker City Town Marshal, Rick seconded, all voted in favor.

Scott made a motion to accept Resolution 2024-6 Appointing Mick Deckman as Water Department Superintendent, Jimmy Wyman as Sewage Department Superintendent, Rick seconded, all voted in favor.

Scott made a motion to accept Resolution 2024-7 appointing Meeks Cockerill as Town Attorney, Rick seconded, all voted in favor. The Town Attorney contract and the conflict of interest statement for 2024 was signed.

Clerk bonds were presented for Kim and Sandra both in the amount of \$30,000.00. Scott made a motion to accept the bonds, Rick seconded, all voted in favor.

Scott made a motion to sign the fire contract with Parker Volunteer Fire Department in the amount of \$27,000.00 plus \$5,000.00 for the 1st Responders, and \$5320.00 for insurance for year 2024, Rick seconded, all voted in favor.

Scott made a motion to accept the payroll claim docket, Rick seconded, all voted in favor.

Scott made a motion to accept the claim docket for all other claims, Rick seconded, all voted in favor.

Rick made a motion to appoint William as the Parker City Town representative for the Area Planning Commission for 2024, Scott seconded, all voted in favor.

Bobbie Hood representing the Kat Krusaders spoke about their work on becoming a 501c3 entity. There is not a Humane Society in Randolph County and they are looking for a building for this purpose. They are looking for Organizations to help with donations to continue the Spay/Neuter Program that they have been working on in Parker City.

Sandra stated that we are continuing to work on the details for a 3 day event for the solar eclipse in April 2024.
